

LEGAL NEWS



You've probably heard about a new MLS Rule – more specifically, MLS Statement 8.0, the Clear Cooperation policy. The new policy, adopted in November by the National Association of REALTORS®' Board of Directors, requires listing brokers who participate in a Multiple Listing Service to submit their listings to the service within one (1) business day of publicly marketing the property.

I get questions about this policy on the Legal Hotline constantly. That is totally OK. In fact, I encourage them! But I want members to be aware of the great resources available on many topics, including this one, on the National Association of REALTORS®' website.

Here are some links on NAR's website that answer many questions about this policy, as well as some other topics that often come up on the hotline. Take 15 minutes today and check them out!





